If the event is cancelled for any reason, the nonrefundable retainer is forfeited. If the scheduled event takes place on the original scheduled date the client is still liable for the payment in full.

DAMAGE TO PROVIDER'S EQUIPMENT

Client acknowledges that they shall be responsible for any damages or stolen equipment of S.W.S. Photo Booth, from their guests while at the event.

LIMITED LIABILITY:

The undersigned agrees that any and all actions for damages by the undersigned of any kind whatsoever including but not limited to breach of contract, equipment failure and or negligence acts of, by or through Swensen Photobooth Rental including but not limited to its employees, associates, helpers, and or camera person or persons, is LIMITED TO A FULL REFUND OF THE "PRICE", MINUS THE NONREFUNDABLE "RETAINER".

The undersigned agrees that if any technical difficulty occurs, Swensen's Photo booth Rental has one hour to replace or repair the equipment. If the replacement or repairs exceeds the one hour time limit a proration of the cost will be applied excluding the retainer. Client also understands that each service Swensen's provides it is a separate service, even if bundle discounts are applied. This contract in no way shall be changed nor will it create a change to any other contract of a service we provide. Swensen's will determine how bundle discounts are applied to each service.
