1. Upon CLIENT'S signature, SWS will reserve the time and date agreed upon, and will not make other reservations for that time and date. For this reason, the Reservation Deposit of \$ _____ is non-refundable. The Reservation Deposit is applied towards the contracted wedding photography package. THE CLIENT understands and agrees to make an additional payment of \$ _____ 30 days prior to the wedding date. THE CLIENT understands and agrees to make an additional payment of \$ _____ the day of the wedding.
2. 30-90 days after the wedding, SWS will provide THE CLIENT with a CD of all digital photos taken at the event. If THE CLIENT wishes to order prints or albums, extra fees will be applied.
3. Client also understands that each service SWS provides it is a separate service, and even if bundling discounts are applied, this contract in no way shall be changed nor will it create a change to any other contract of a service we provide. SWS will determine how any bundle it discounts are applied to each service
4. The undersigned agree that cancellations must be received in writing at least 90 days prior to the scheduled event. Non complying cancellations do not absolve the undersigned from their obligation for full and prompt payment. If scheduled event takes place you are still responsible for payment in full to SWS.
5. The photographs, digital negatives or prints produced by SWS are protected by U.S. Copyright Law (all rights reserved). Upon final payment, THE CLIENT is granted limited copyright ownership of the images under the following conditions. THE CLIENT grants SWS the right to use the photographs for editorial, advertising or internet promotions.
6. SWS warrants and declares that every effort will be made to provide high quality photographic services. In the unlikely event of severe medical, natural, or other emergencies, it may be necessary to retain an alternative photographer. SWS will make every effort to secure a suitable replacement photographer willing to provide a similar package. If such a situation should occur and a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the event package. SWS takes the utmost care with respect to exposure, transportation and processing of photographs. However, in the unlikely event of THE CLIENT'S photographs being lost, stolen or destroyed for reasons within or beyond SWS control, the latter's liability is limited to the return of all payments received for the event package. The limit of liability shall not exceed the contract price stated herein. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals.
7. Although every possible care will be taken to produce photographs of all important and special events during the wedding, SWS cannot place an unconditional guarantee on the above. SWS will not be held responsible for any ruined photographs due to guests' (or any other) flashes; or any other ruined photographs due to any other cause in or outside of SWS control. Especially and including ceremony restrictions, and or lack of cooperation from band, coordinator or non-SWS DJ/Videographer.
